NXP STREAMLINES TAX PROCESSES

COMPANY OVERVIEW

NXP (NASDAQ: NXPI) manufactures and designs semiconductors that enable secure connections for a smarter world. The company, with operations in over 25 countries, is a global market leader in areas as diverse as automotive chips for in-vehicle networking, passive keyless and immobilisation, silicon tuners for TV and set-top boxes, and contactless transport and access management, and eGovernment applications such as ePassports. Focusing on high-growth application segments fueled by key mega-trends, NXP posted revenue of \$4.36 billion in 2012 and is on pace to outgrow the industry.

NXP'S CHALLENGE

NXP needed a solution that would provide an accurate overview of the company's tax situation. The preparation of and insight into tax returns became a complicated process due to dependence on cumbersome spreadsheets to assess tax liability, including working with numerous additional sheets at any one time.

When tax manager Paul van Sloun joined the company and was faced with the preparation of complex tax returns, he quickly realised that the use of spreadsheets would lead to problems and began a review of corporate tax software to find a solution that could handle NXP's exacting demands.

Having rejected a number of solutions that were only capable of submitting tax returns, a colleague and fellow user of ONESOURCE Corporate Tax recommended the software and suggested that Paul visit him to see it in action.

"Within an hour, I was convinced it was the package we had to buy," said Van Sloun. "It offers the clarity and insight we need as an organisation, forcing you to



think in a logical and mathematical way. And as long as you maintain the structure, you can deal with very complex fiscal situations and tax returns."

TAKING TRANSPARENCY TO A NEW LEVEL

The tax authorities in the Netherlands are looking for ever greater transparency. 'Horizontal monitoring' ensures companies have strict processes in place supported by a rigid tax control framework. This puts increased pressure on companies like NXP to "show what they are doing and clearly state where the numbers come from", according to Van Sloun.

Following the implementation of ONESOURCE Corporate Tax in 2012, NXP has taken this a stage further and in an ultimate demonstration of transparency, has given the tax authorities access to the live tax software.

"We are one of the first companies in the Netherlands to offer the tax authorities access to our corporate tax solution. We want to be completely transparent. They visit our premises, we give them a laptop and load ONESOURCE and they can check exactly where the numbers are coming from and how the tax return is put together," adds Van Sloun.
